**Bid Notice 2026-02:** The Village of Jemez Springs seeks to have a qualified contractor design and construct improvements to the main entrance and the conference room entrance at the Jemez Springs Public Library.

- ✓ Only Bidders that complete and return the enclosed Acknowledgement of Receipt Form will receive addendums, if issued.
- ✓ Bids must be received in the Village Office by the Response Deadline date and local time as indicated. ***Bids that are received after that date and time will not be accepted and will be returned to the sender unopened.***
- ✓ Bid Offers shall be made on unaltered Bid Offer Forms furnished by the Village of Jemez Springs. ***Emailed Bids are not accepted.*** Bids shall be submitted sealed. The outside package should clearly identify the project name and bid number, bid opening date, and name of bidder. Submit Bid Offer in accordance with the Invitation to Bid.
- ✓ Failure of bidders to complete bidding documents in accordance with all instructions provided is cause for this office to reject bids.
- ✓ Brand names and numbers, if provided, are for reference only, equivalents will be considered. If bidding equivalent, bidders must be prepared to furnish complete data to prove product meets or exceeds specifications of the bid item.

## **SPECIFICATIONS AND REQUIREMENTS**

### **1. MAIN ENTRANCE**

Demo existing decking and support structure

- Reconstruct support structure with treated material, as needed

- Remove, sand, paint, and reinstall existing railing

- Maintain existing step configuration

- Move sign structure east one foot

- Replace wood decking with composite material

- Replace skirting with sturdy material

Demo existing wood ramp

- Install ADA compliant concrete ramp

- Remove, sand, paint, and reinstall existing railing

Renew finish on round structural supports

Paint 2 handicapped parking spots near end of ramp on existing parking lot

### **2. CONFERENCE ROOM ENTRANCE**

Extend porch roof east approximately 2 feet

- Install round support posts consistent with library main entrance

- Match existing roof and gable material and trim

- Install, stucco, paint on new gable and trim

- Replace existing signage on new gable

- Install and paint soffit using concrete sheet material

Extend porch deck and steps approximately 2 feet east and south

- Reconstruct support structure with treated material, as needed

- Install composite decking with metal railing consistent with library main entrance

- Install gutters on north end of roof over ramp

Demo existing wood ramp

- Install ADA compliant concrete ramp

- Install metal railing consistent with library main entrance

Paint 2 handicapped parking spots near end of ramp on existing parking lot

**IN-STATE RESIDENT OR NATIVE AMERICAN RESIDENT BUSINESS PREFERENCE.** To be eligible for the 10% resident business or Native American resident business preference, the bidder shall include a valid copy of their certificate with their bid and in-state resident preference number on the Bid Offer Page, pursuant to Section 13-4-2 NMSA 1978. Each Bidder may obtain a New Mexico In-State Resident Contractor Preference Certificate Number through the State of New Mexico, Department of Taxation and Revenue, 505-827-0951.

**RESIDENT VETERAN PREFERENCE.** To be considered for the 10% resident veteran business preference, the bidder shall include a valid copy of their certificate with their bid and in-state veteran preference number on the Bid Offer Page, pursuant to Section 13-4-2 NMSA 1978. Each Bidder may obtain a Resident Veterans Preference Certificate Number through the State of New Mexico, Department of Taxation and Revenue, 505-827-0951. This preference is separate from the in-state preference and is not cumulative with that preference.

**TAX EXEMPT STATUS.** The Village of Jemez Springs is tax exempt on tangible personal property. Tax shall not be applied to purchase of these items. The Village will provide a tax exemption certificate upon request and after receiving the Contractors state business taxpayer identification number (old CRS number). Applicable taxes on services, if any, shall be identified as a separate line item on the invoice. Construction under this bid is fully taxable.

**CODES/LAWS/REGULATIONS.** The Contractor shall be properly licensed and shall comply with all applicable Federal, State and local government codes, laws, regulations, and requirements in the performance of the work described herein. The procurement code sections 13-1-28 through 13-1-99 NMSA 1978, impose civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for bribes, gratuities and kickbacks.

**GOVERNING LAW.** Any agreement awarded to a Contractor, as a result of this solicitation, shall be governed in accordance with laws of the State of New Mexico.
