## **Jemez Springs Village Council Emergency Meeting Minutes Monday June 29, 2026, 6:00 PM Governing Body Conference Room**

1. **Call to Order** - Mayor Nealeigh called the meeting to order at 6 p.m.

**Council Members Present:** Mayor Michael Nealeigh, Trustee Judy Boyd (via phone), Trustee Victoria Martinez, Trustee James McCue, and Trustee Robert Wilson.

**Also in Attendance:** Interim Clerk Heather Gutierrez, Police Chief Joe Moreno, Fire Chief Mano Sanchez, IT Consultant Fred Simmank and members of the public Tonya Yudizky, Amy Yuditzky, Travis Merrill, Jane House, Peg Froelich, James Colovos, Brandan Voch, Kelly Stokes, and Ruben Romen.

2. **Certificagtion of Public Notice** - Mayor Nealeigh opened the meeting by explaining that earlier in the day he met with Department of Homeland Security Emergency Management personnel and was advised that a request for assistance needs to be preceded by a declaration of a state of emergency by the municipal governing body. Acting on that advice Mayor Nealeigh called an emergency meeting of the Village Council and the Interim Clerk posted public notices in the established Village locations and social media sites.

Mayor Nealeigh reported that although the Emergency Meeting Notice indicated two items of business, only the emergency declaration will be addressed. He learned while preparing a resolution to ban fireworks that such action required 20 days public notice prior to a holiday when fireworks are customarily used and a public hearing.

3. **New Business** - Consideration of Emergency Declaration.

Mayor Nealeigh introduced Resolution 2026-018 – A Resolution Declaring a State of Emergency Due to Major Storm and Flooding Event by describing the damage to residences and public infrastructure from the storm-initiated flash flood of June 26, 2026. A motion to adopt the resolution was made by Trustee McCue and seconded by Trustee Boyd. Following a brief discussion among Trustees and comments from those attending a roll call vote was taken.

Trustee Wilson – aye

The motion carried and the Resolution was approved.

4. **Adjourn** - Mayor Nealeigh adjourned the meeting at 6:31p.m.
